THE Government of the Republic of Zambia, through its Public Expenditure Management and Financial Accountability programme under Ministry of Finance and National Planning, is rolling out a far reaching programme of reforms that will improve the way in which public finances are managed, making better use of tax payers' money and providing real benefits for its citizens across the country. In this respect, the Government of the Republic of Zambia has received funding from a group of donors, known as the Cooperating Partners supporting PEMFA (Norway, the Netherlands, Germany, Sweden, Finland, Ireland, Denmark, United Kingdom, European Commission, International Development Association, United Nations Country Team of Zambia, African Development Bank and the Government of the United States of America), towards the cost of the PEMFA Programme and it intends to apply the proceeds to payments for goods, works and services to be procured under this programme.

The Zambia Public Procurement Authority is responsible for controlling and regulating public procurement in Zambia as prescribed by the Public Procurement Act, No. 12 of 2008. Under PEMFA, the Authority is implementing public procurement reforms whose overall objective is to promote and institutionalise a transparent, accountable and efficient public procurement system in order to improve expenditure management. Confidence of civil society, international community and other stakeholders in the procurement system is critical to the reforms.
