The Pilot is aimed at testing the Census methodology as well as the instruments with particular emphasis on the use, handling and processing of Optical Mark Reading (OMR) Forms for the forthcoming National Census of Population and Housing, scheduled for August, 2010. Data for the Pilot Census will be collected on an OMR Form covering General Characteristics and Personal Information. The topics to be covered include:

**General Characteristics:**

Questionnaire Identification, Area Identification, Household Listing, Housing Characteristics, Household Characteristics, Agriculture, etc.

**Personal Information:**

Full Name, Membership Status, Relationship to Head of Household, Sex, Age, Birthplace, Citizenship, Purpose of Stay (Non-Zambians only), Religion, Residence, Migration, Ethnicity, Predominant Language of Communication, Education Level, Economic Activity, Employment Status, Occupation, Industry, Marital Status, Fertility, Mortality, National Registration and Electoral Information, etc.

All households residing within the selected Standard Enumeration Areas are obliged by law to furnish the necessary information to the enumeration staff from the Central Statistical Office. The information so collected will be kept strictly confidential and used for statistical purposes only.
