IN EXERCISE of the powers contained in sections twelve, thirteen, sixteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three of the Value Added Tax Act, the following Rules are hereby made:

Title (Gazette Notice No. 86 of 1997)

1. (1) These Rules may be cited as the Value Added Tax (General) (Amendment) Rules, 2012, and shall be read as one with the Value Added Tax (General) Rules, 1997 in these Rules referred to as the principal Rules.

Amendment of Third Schedule

2. The Third Schedule to the principal Rules is amended by the addition of the eligible items listed in the Table set out in the Appendix to these Rules.
