Road Development Agency**Public Notice — Illegal Structures on Road Reserves**

The Road Development Agency Plans to commence detailed study and design of the dual carriage way from Lusaka to Kapiri Mposhi for November 2012 until May 2013. The Agency further wishes to inform the general public that it has completed the detailed design of the Dual Carriage Way between Kitwe and Chingola. In view of these planned works, the Road Development Agency wishes to warn the Local Authorities and members of the General public that all illegal structures that have been erected on Road Reserves along the stretch earmarked for the construction of the Dual Carriage Way will be demolished without compensation. The RDA is only obliged under the Law to compensate Land Owners whose land has been taken away for purposes of immediate or future road development

The Road Reserves includes the land which is 91 meters from the centre of the Trunk Road on both sides where the Agency wishes to develop.

The RDA further wishes to notify all Local Authorities, advertising Agencies and the members of the general public that it is an offense under the Public Roads Act No. 12 of 2002 Sections 43, 44, 45 and 46 to erect structures in the road reserve without written authorization from the Agency.

The Public Roads Act No. 12 of 2002 further provides as follows:

46. (1) Where on any land reserved in terms of section *forty-three* or *forty-four* any person does any act calculated to impede the purposes for which the land has been reserved or which the person has not been authorized by the Director to do, the Director may, by notice in writing, direct the person, at the person's own expense and within such period as shall be specified in the notice, to restore the land to the condition in which it was immediately before the unauthorized act.

(2) If the person fails to comply with the direction within the period specified under subsection (1), the person commits an offence and is liable, on conviction, to a fine not exceeding one thousand five hundred penalty units or to imprisonment for a period not exceeding three months or to both.

(3) The Director may cause to be carried out such works as may be necessary to restore the land and may recover from the person any expense incurred in the work.
