#### Notice of Withdrawal from Circulation of the Existing Banknotes and Coins

IT IS HEREBY NOTIFIED for public information, pursuant to Section 34 of the Bank of Zambia Act, Chapter 360 of the Laws of Zambia that with effect from 1st January 2013, the Bank of Zambia shall

start withdrawing from circulation the existing currency, consisting of banknotes and coins, and exchanging it with the redenominated currency, also consisting of banknotes and coins.

The public is further informed that:

From 1st January 2013 to 30th June 2014, the withdrawal and exchange of the existing currency for the redenominated currency shall be done at the offices of Bank of Zambia, registered financial service providers or at any other place designated for that purpose by the Bank of Zambia;

Thereafter, from 1st July 2014 to 31st December 2015, the exchange of the existing currency for the redenominated currency shall only be done at Bank of Zambia offices;

The existing currency, consisting of banknotes and coins, will cease to be legal tender on 1st July 2013, and thus become demonetised on that same date. However, the existing currency will remain available for exchange, as stipulated in paragraph 1 and 2 above, with the redenominated currency on face value.

THE Government of the Republic of Zambia has received a credit from the International Development Association towards the cost of the Road Rehabilitation and Maintenance Project Phase II and intends to apply part of the proceeds of this credit to eligible payments under the Contract for which this invitation for bids has been issued.
