The Local Government Elections, Regulations, 1991

IN EXERCISE of the powers contained in Section 6(1) and (2) of the Local Government Elections Act, Cap. 282 of the Laws of Zambia and in pursuance of Regulation 4(1) of the Local Government Elections Regulations, 1991.
