THE Government of the Republic of Zambia has received a credit from the International Development Association (IDA) towards the cost of Increased Access to Electricity Service Project, and it intends to apply part of the proceeds of this credit to payments under the Contract for Supply and deivery of Various Steel.

ZESCO Limited now invites sealed bids from eligible and qualified bidders for Procurement of Various Steel.
