**Zambia Electricity Supply Corporation Limited****Tender Zesco/078/2013: Expression of Interest for the Development and Design of Brand Guideline Manual and Rebranding of ZESCO Limited.****Background**

ZESCO Limited, a vertically integrated Power Utility established in 1970, is wholly owned by the Government of the Republic of Zambia. The Company has invested extensively in Power Generation, Transmission and Distribution infrastructure throughout Zambia as follows:

- (i) In the generation business, Zesco has the following power stations among others: Kafue Gorge (990MW), Kariba North Bank (720MW), Victoria Falls (108MW), four Small Hydro Power Stations namely Lusiwasi (12 MW), Musonda Falls (5MW), Chishimba Falls (6MW), Lunzua (750KW), and a total of nine Diesel Power Stations; Lukulu, Luangwa, Zambezi, Mufumbwe, Mwinilunga, Kabompo, Chavuma, Shango'mbo and Kaputa.
- (ii) In the transmission business, ZESCO has a network comprising Transmission Lines exceeding 7,231 Km and over 60 Transmission Substations spread across Zambia.
- (iii) The Distribution business has a countrywide distribution network with a total installed capacity of slightly over 1500MVA.

ZESCO Limited seeks consultancy services for the development, design and implementation of a brand guideline manual and rebranding of the corporation. ZESCO would like to apply standards and sustainably maintain consistency in the use of all its corporate identity in line with its corporation culture reflected in the company's core-ideology. The aim is to have ZESCO's corporation identity to act as a guarantor of consistent quality and contribute to the loyalty of customers and other stakeholders.

Therefore, ZESCO has set aside resources from its own internally generated funds to be used to finance the consultant to develop and design a brand guideline manual and implement the rebranding of the corporation.

**Objective**

The objective of this tender floating is to seek consultancy services for the development, design and implementation of a brand guideline manual and rebranding of the corporation in line with its ideology. The brand manual will form the basis for the communication policy implementation.

**Scope of Work**

The assignment will include but not limited to the development and roll out of a new or renewed corporate identity and a comprehensive corporation brand manual; development of a sustainable brand internalization strategy and road map throughout the entire organisation; capacity building within ZESCO to sustain the brand in the brand internalization programme for the long term; develop/propose measurement tools such as key performance Indicators and monitoring mechanisms for brand performance to be managed by ZESCO in the long term; develop a comprehensive brand internalization manual; and address any other issue (s) incidental and related thereto. The service will also entail the periodic objective measurement of the impact of the re-branding exercise for management reports.

Broadly, the assignment shall include the following activities:

**Qualifications**
