The Animal Health Act (Laws, Volume 27 of 2010)

African Swine Fever Outbreaks in Kalomo District of Southern Province of Zambia

In Accordance with the provisions of the Animal Health Act No. 27 of 2010 of the Laws of Zambia, it is notified for the information of the public in general and the farming community in particular that African Swine Fever a disease of domestic and wild pigs has broken out in Kalomo District of Southern Province of Zambia.

In view of this occurrence the under listed measures will be in force in the whole of Kalomo District with immediate effect until further notice.

- 1. Movement of all pigs and pig products within and out of the affected areas have been banned as follows:
 - (a) No pigs or pig products will be allowed to move within or into Kalomo District;
 - (b) No pigs or pig products will be moved from Kalomo District to any other district of Southern Province as well other districts of the country;
 - (c) Veterinary Officers in the affected areas will take any other such measures as deemed necessary for the control of the disease;
- All pig slaughter facilities and processing plants in Kalomo district have been closed with immediate effect until the disease is

Any animals found contravening the foregoing measures will be destroyed without compensation and the persons in charge of such animals will be prosecuted. Any other person or persons found contravening the measures directly or indirectly would also be prosecuted.
