Determination of Charges and Fees by Zambia Airports Corporation Limited

PURSUANT to section twenty-seven of the Aviation Act, Chapter 444 of the Laws of Zambia and in consultation with the Ministry of Transport, Works, Supply and Communications as required by the said Act, It is hereby notified that the fees, charges and other matters set out in the Schedule below shall apply from the 1st July, 2015.

FEES, CHARGES AND OTHER MATTERS

(a). *Air Navigation Service Charges*

- i. The constant used in the formula to calculate international navigation charges shall be adjusted from US\$ 12.00 to US\$ 15.00 in 2015 and from US\$ 15.00 to US\$ 20.00 in 2016.
- ii. Domestic navigation charges shall remain at 15 percent of domestic landing charges.

(b). *Landing Charges*

- i. The day landing charges for all domestic and international flights at the four designated airports namely Kenneth Kaunda, Simon Mwansa Kapwepwe, Harry Mwaanga Nkumbula and Mfuwe International Airports shall be adjusted upwards by 25 percent (E.g. an aircraft with a maximum takeoff weight (MTOW) of 1,000 kilograms which previously paid US\$ 12.50.

NOTE: The minimum landing charge for international flights shall be US\$ 12.00 and minimum landing charges for domestic flights shall be US\$ 10.00.

Day landing shall be the period from 0600 to 1800 hours local time.

- i. Night landing charges for Kenneth Kaunda International Airports shall be reduced by 5 percent to encourage the spread of traffic in the night.
- ii. Night landing charges for Simon Mwansa Kapwepwe, Harry Mwaanga Nkumbula and Mfuwe International Airports shall be increased by 10 percent of new day rates.

(c). Parking charges at all the designated airports shall have a minimum charge of US\$ 5.00 per hour for both domestic and international flights.
