The Value Added Tax Act

(Laws, Volume 19, Cap. 331)

The Value Added Tax (General) (Amendment) (No. 4) Rules, 2015

IN EXERCISE of the powers contained in *sections twelve, thirteen, sixteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three* of the Value Added Tax Act, the following Rules are hereby made:

Title and commencement (Gazette Notice No. 86 of 1997)

These Rules may be cited as the Value Added Tax (General)(Amendment) (No.4) Rules, 2015 and shall be read as one with the Value Added Tax (General) Rules, 1997, in these Rules referred to as the Principal Rules.

Amendment of third Schedule

The Third Schedule to the principal Rules is amended by the addition of the items listed in the Table set out in the Appendix to these Rules.
