The Public Service Pensions Fund (PSPF) has set aside some funds toward the cost of replacing its data storage systems and it intends to apply part of the proceeds of this financing to eligible payments under the contract resulting from this IFB: Tender for the Supply, Delivery, Installation, Configuration and Commissioning of two (2 No.) Data Storage Systems at PSPF Head Office and Disaster Recovery Site, Kalundu, Lusaka and provision of related services.

PSPF has implemented Microsoft Dynamics-NAV, Enterprise Resource Planning (ERP) system and the Pension Administration System (ZAMM) which store data on Microsoft SQL 2005. Both systems have been implemented on a NetApp/Windows platform. The operating system for the Microsoft Dynamics-NAV is Microsoft Windows 2008 Server. The NetApp is a Storage Area Network (SAN) which houses the Microsoft SQL 2005 Server. The NetApp SAN runs the Data ONTAP version 7 operating system.

The workstations are connected to the PSPF routed and switched backbone using Cisco Routers and Cisco Switches. A combination of fibre and copper is used throughout. The PSPF backbone is configured in a star topology utilizing 10Mbps, 100Mbps and 1000Mbps Ethernet. Protocols carried over the network are TCP/IP.

Standards based SMTP and POP3 are the PSPF's primary email systems. Outlook is used as the email client and Microsoft Exchange 2010 Server is the main email solution.

Domain Name Services (and Secondary DNS Services) are provided by a name server running Windows 2008 Microsoft Active Directory. Microsoft IIS and Web servers running on Windows 2008 Server platforms provide web services. The systems have been implemented in VMware virtualization environment that is running on HP blade servers.

PSPF's current Netapp Storage systems have reached end of life and no longer supported. Hence, the need to have them replaced.

PSPF now invites sealed bids through open national bidding from eligible bidders for the Supply, Delivery, Installation, Configuration and Commissioning of two (2 No.) Data Storage Systems at PSPF Head Office and Disaster Recovery Site, Kalundu, Lusaka and provision of related services. Qualifications requirements are as follows:

The Bidder must be a partner of the products to be supplied, The Bidder should provide qualifications of at least two (2 No.) Engineers with two of any of the following qualifications
