# The Banking and Financial Services (Capital Adequacy) Notice, 2016

IN EXERCISE of the powers contained in section *Eighty Three* of the Banking and Financial Services Act, the following Notice is hereby made:

#### Short title and Commencement

1. This Notice may be cited as the Banking and Financial Services (Capital Adequacy) Notice, 2016 and came into operation on 9 January 2014.

#### Capital Adequacy Requirements

2. A development finance institution shall commence operations with primary capital of not less than Kwacha Seven Hundred and Fifty Million, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

3. A housing finance institution shall commence operations with primary capital of not less than Kwacha Fifty Million, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

4. A savings and credit institution shall commence operations with primary capital of not less than Kwacha Fifty Million, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

5. A deposit-taking leasing company shall commence operations with primary capital of not less than Kwacha Fifty Million, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

6. A non-deposit taking leasing company shall commence operations with primary capital of not less than Kwacha Five Million, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

7. A deposit taking microfinance institution shall commence operations with primary capital of not less than Kwacha Two Million Five Hundred Thousand, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

8. A non-deposittaking microfinance institution shall commence operations with primary capital of not less than Kwacha One Hundred Thousand, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

9. A bureau de change shall commence operations with primary capital of not less than Kwacha Two Hundred and Fifty Thousand, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

10. A credit reference bureau shall commence operations with primary capital of not less than Kwacha One Million Five Hundred Thousand, or such other higher amount as may be prescribed by the Bank of Zambia from time to time and shall maintain this minimum amount at all times.

11. A development finance institution, housing finance institution, savings and credit institution, deposit-taking leasing company and non-deposit taking leasing company shall maintain the minimum prescribed capital or an equivalent of 10 percent of the institution's risk weighted assets, whichever is higher.

12. A deposit-taking microfinance institution and non-deposit taking microfinance institution shall maintain the minimum prescribed capital or an equivalent of 15 percent of the institution's risk weighted assets, whichever is higher.

13. The minimum primary capital requirement shall be made up of at least *eighty* percent in nominal paid-up common shares (nominal paid-up equity capital) and the balance may be held only in any one or more of the following:

- (i) Share premium or contributed surplus as verified by an independent auditor;
- (ii) Retained income (retained earnings) as verified by an independent auditor;
- (iii) General Reserves as verified by an independent auditor; and

(iv) Statutory reserves as verified by an independent auditor.

14. A development finance institution, housing finance institution, savings and credit institution, deposit-taking leasing company, non-deposit taking leasing company, deposit taking microfinance institution, non-deposit taking microfinance institution, bureau de change and credit reference bureau which did not meet the revised minimum primary capital requirements on the date of coming into effect of the new capital adequacy framework have a transitional period of up to 31 December 2016 to build up their primary capital to the required amount.
