Revocation of the Non-Deposit Taking Microfinance Institution Licence of Nu-Bridge Financial Services Limited

TAKE NOTICE that with effect from 14th June, 2016 the Deputy Registrar of Banks, Financial Institutions and Financial Businesses revoked the non-deposit taking microfinance institution licence of Nu-Bridge Financial Services Limited. The revocation follows the intention by Nu-Bridge Financial Services Limited to voluntarily cease operations and wind up.

The revocation of the licence entails that Nu-Bridge Financial Services Limited has ceased to operate as a microfinance institution under the Banking and Financial Services Act and the Banking and Financial Services (Microfinance) Regulations, 2006. However, the revocation of the licence does not relieve Nu-Bridge Financial Services Limited of any obligations it incurred or assumed during the period of validity of the licence.
