Rules, 2018

Title and Commencement

1. (1) These rules may be cited as the Value Added Tax (General) (Amendment) Rules, 2018 and shall be read as one with Value Added Tax (General) Rules, 1997, in these Rules referred to as the Principal Rules.

2. These Rules shall come into operation on 1st April, 2018.

Amendment of Rule 18

3. Rule 18 of the principal Rules is amended by the insertion of the following new sub-rules, immediately after sub-rule(1):

(2) A taxable supplier shall, within six months from the date of export, produce the documents referred to in sub-rule (1), to an authorised officer.

(2A) Where a taxable supplier fails to produce the documents within the period specified in sub-rule (2), the supply of goods shall be deemed to be standard rated;
