ZESCO Limited, under the guidance of its holding company, the industrial Development Corporation, intends to carry out an organisation restructuring exercise. This includes a re-examination of its strategies, operations and structures in order to identify and implement measures to turn around the company into a commercially viable entity. Achieving this position requires analysis before the best solution is determined and implemented.

**Background**

Organisational restructuring is often driven by significant changes in the organisational strategy or shift in the environment that requires Management of a company to undertake such a large-scale initiative. **Objective**

- (3.) The need to conduct a comprehensive review of the Conditions of Service; and
