The Zambia Information And Communications Technology Authority ("ZICTA")**The Information and Communications Technologies Act
(No. 15 of 2009)****Declaration of Exemption from Requirement to hold an individual Frequency Assignment**

1. The Zambia Information and Communications Technology Authority, pursuant to Section 56 of the Information and Communication Technologies Act No. 15 of 2009, hereby declares that a person required to hold an individual frequency assignment for the use of a Very Small Aperture Terminal (VSAT) shall, save as herein provided, be exempt from the requirement to hold an individual frequency assignment under the Act from January 1 to December 31, 2025.
2. To qualify for the exemption, a person who intends to use a VSAT should obtain a satellite service from a locally licensed electronic communications service provider.
3. A person who qualifies for the exemption shall notify the Authority of their intention to use a VSAT and shall provide the technical details of the VSAT.
4. The Authority shall issue terms and conditions of use for a person who qualifies for the exemption.

This Notice confirms the determination by Zambia Information and Communications Technology Authority (Authority) that certain holders of licences (licensees) issued by the Authority are holding a dominant position in identified relevant electronic communications markets.

The determination was made in accordance with—

- (a) competition procedures and principles for identifying relevant product markets in the electronic communications industry in Zambia;
- (b) share of supply threshold for establishing the existence of a dominant position as set out in the Competition Guidelines of 2021 issued by the Authority pursuant to the ICT Act; and
- (c) Section 15 of the Competition and Consumer Protection Act No. 24 of 2010.
