**The Customs and Excise (Precious Metals) (Export Duty)  
(Suspension) (Revocation) Order, 2024**

IN EXERCISE of the powers contained in section 89 of the Customs and Excise Act, the following Order is made:

1. (1) This Order may be cited as the Customs and Excise (Precious Metals) (Export Duty) (Suspension) (Revocation) Order, 2024.
