One Hundred and Sixty-eighth State Lottery: Unit One

NOTICE is hereby given, for general information that Unit One of the one hundred and sixty-eighth State Lottery will be drawn as a Sweepstake based on the Tote Free Handicap scheduled to be run by the Mashonaland Turf Club, on the 15th September, 1984. The draw will be conducted in public, under the direction of the Minister of Finance at 12.30 p.m. in the State Lottery Hall, Harare, on the 7th September, 1984.

Conditions of draw

- 1. Based on the face value of all tickets sold or issued free, up to 25 per cent. of the total subscriptions may be reserved for social service, public welfare or relief of distress.
- 2. Prizes.

The prize-fund will be distributed as follows-

- \$25 000 to the drawer of favourite horse; \$25 000 to drawer of the horse winning the race; (a)

\$7 500 to drawer of second favourite horse; \$7 500 to drawer of horse that comes second;

\$3 750 to drawer of third favourite horse; \$3 750 to drawer of horse that comes third.

Other horses, in the race, will be paid half the prize after the draw and any of the above prizes or the remaining half, depending on their placing at the race.

The draw for horses will be done in order of favouritism as supplied by the Mashonaland Turf Club on the date of the draw. The most favourite horse will be drawn last. The rules and regulations applicable to the Jockey Club will be strictly applied. In the event of a "dead-heat" for either the first, second or third places, the prize applicable will be combined and divided equally between the ticket holders. In the event that the race is postponed, the prize-money will be paid out on the result of the race that was postponed.

In the event of the race being abandoned for any reason, the prizes applicable to horses will be drawn for as a lottery in a manner to be decided by the Minister. Only the numbers of the tickets which have been drawn, a horse will be included in this draw.

The remainder of the prize-money will be distributed in smaller ordinary introducer's, introducer's jackpot, and consolation prizes. If, in the opinion of the Minister of Finance, the prize-fund is insufficient for the purpose, the amounts of the first three prizes listed above will be reduced as directed by that Minister.

(c) Twó introducer's jackpot prizes: Prize, \$50; introducer, \$500

Only tickets issued against one written order for 14 tickets in one unit are eligible to win these prizes, provided that such written order has been compiled at one and the same time. Prizes not won will be carried forward and used to increase the jackpot prizes in the following unit. These prizes will be drawn after the draw for ordinary prizes has been completed.

3. Double and treble prizes
