ROAD MOTOR TRANSPORTATION ACT [CHAPTER 262]

Applications in Connexion with Road Service Permits

IN terms of subsection (4) of section 7 of the Road Motor Transportation Act [Chapter 262], notice is hereby given that the applications detailed in the Schedule, for the issue or amendment of road service permits, have been received for the consideration of the Controller of Road Motor Transportation.

Any person wishing to object to any such application must lodge with the Controller of Road Motor Transportation, P.O. Box 8332, Causeway—

(a) a notice, in writing, of his intention to object, so as to reach the Controller's office not later than the 22nd May, 1987;

(b) his objection and the grounds therefor, on form R.M.T. 24, together with two copies thereof, so as to reach the Controller's office not later than the 12th June, 1987.

Any person objecting to an application for the issue or amendment of a road service permit must confine his grounds of objection to matters directly bearing on the considerations referred to in paragraph (a), (b), (c), (d), (e) or (f) of section 8 of the said Act.

Your directors have pleasure in advising that the Group's unaudited net operating income, after provision for taxation and after transfers to internal reserves, reached the record level of \$3 868 000 for the six months period ended 31st March, 1987. This is an increase of \$478 000 or 14,1 per cent. over the results for the comparable period last year. Earnings per share rose from 25,90 cents to 29,55 cents.

These results must be considered as highly satisfactory given the much slower rate of economic growth last year and continuing difficult economic conditions. The prolonged drought has severely affected agricultural output this season which, together with the effects of the cuts in foreign exchange allocations on industry and commerce generally, means that the second half of the year will be even more difficult. However, the latter half of the financial year is traditionally the more profitable and your directors are confident that, notwithstanding the problems facing the Zimbabwean economy, Group results for the full year will continue at a satisfactory level.

Dividend announcement

Given the present difficult conditions it is prudent to adopt a conservative view. Accordingly, the directors have decided to maintain the interim dividend at last year's level and have declared an interim dividend in respect of the six months ended 31st March, 1987 of 11 cents (1986—11 cents) per share payable to shareholders registered in the books of the Company at the close of business on Friday, 8th May, 1987.
