EMPLOYMENT COUNCIL FOR THE TEXTILE INDUSTRY

FURTHER AGREEMENT

This further agreement, made and entered into in accordance with the provisions of the Labour Relations Act No. 16 of 1985, between the Central African Textile Manufacturers

Association of the one part, and the Zimbabwe Textile Workers' Union of the other part, being parties to the National Employment Council for the Textile Industry, shall be read as one with the agreement published in Statutory Instrument 555 of 1983, as amended and extended.

Clause 4-Definitions

By the deletion of (m) of the definition of "textile industry" and replacement by the following:

"Manufacturing articles from jute and other fibres and/or the recovering or repairing of same.".

Clause 9—Wages and Grading

By the deletion of subclause (7) and replacement by the following:

- "(7) (a) For the purpose of determining his wage-entitlement, no employee shall be demoted to a lower level until the expiration of one calendar month's written notice from his employer; accordingly, an employee who, without being formally demoted, is required to perform work in a lower level than his normal one, shall be entitled to the wage applicable to the higher level.
 - (b) For the purposes of disciplinary action, no employee shall be demoted other than for reasons as specified below:

Where the employer has good cause to believe that an employee is guilty of—

- (i) any act, conduct or omission inconsistent with the fulfilment of the express or implied conditions of his contract; or
- (ii) wilful disobedience to a lawful order given by the employer; or
- (iii) wilful and unlawful destruction of the employer's property; or
- (iv) theft or fraud; or
- (v) intoxication that renders him incapable of performing his duties properly; or
- (vi) absence from work for a period of five or more working days without reasonable excuse; or
- (vii) habitual and substantial neglect of his duties; or
- (vii) gross incompetence or inefficiency in the performance of his work; or
- (ix) lack of skill which the employee expressly or impliedly held himself out to possess.
- (c) In the event of demotion of any nature, the employer shall specify the period for reviewal, where deemed necessary.

Clause 26-Gratuities

By the deletion of subclause (4) and replacement by the following:

"Notwithstanding the provisions of subclauses (1), (2) and (3), the amount of gratuity to which every employee shall be entitled in terms of this clause, shall be calculated on his/her actual wage or salary at the time of retirement or termination of service with the employer."
