MINES AND MINERALS ACT [CHAPTER 165]

Exclusive Prospecting Order No. 713: Gweru Mining District

THE following order is published in terms of subsection (2) of section 92 of the Mines and Minerals Act [Chapter 165]:

"I, Jonas Christian Andersen, Minister of Mines, with the 1, Jonas Christian Andersen, Minister of Mines, with the approval of the President, hereby, in terms of subsection (1) of section 92 of Mines and Minerals Act [Chapter 165], make an exclusive prospecting order, in favour of Reunion Mining (Zimbabwe) Limited over the area described hereunder, in the Gweru mining district, in relation to maps references Leopard Mine 1829 C3 and Silobela 1829 C4, both of the Second Edition and of the scale 1:50 000, produced by the Surveyor-General, subject to the following conditions—

- (a) the order is made in respect of gold;
- (b) the concession holder shall carry out prospecting operations in a manner satisfactory to the Minister of Mines.

Reunion Mining (Zimbabwe) Limited is authorized, in terms of subsection (4) of section 94 of the Mines and Minerals Act [Chapter 165], to prospect on all registered base mineral blocks which were not being worked on the 20th December, 1990, being the date of the lodging of the application for this order.

Description of area

An area of approximately 31 355 hectares situated in the Gweru mining district and bounded by a line commencing at a point on the main Kwekwe to Nkayi Road (which is approximately 9 kilometres east-north-east of Silobela) (grid reference 35KQK503019); thence proceeding on a true bearing of approximately 235° 30′ for a distance of approximately 5,10 kilometres to the intersection of two fence lines (grid reference QI461990); thence on a true bearing of approximately 3° 15′ for a distance of approximately 11,50 kilometres to a point on a narrow gravel road (grid reference QK467105); thence on a true bearing of approximately 309° for a distance of approximately 16,2 kilometres to the intersection of three fence lines and a narrow gravel road (grid reference QK339206); thence on a true bearing of approximately 302° 30′ for a distance of approximately 6,4 kilometres to the intersection of narrow gravel road and a track mately 302 30 for a distance of approximately 6,4 knometres to the intersection of narrow gravel road and a track (grid reference QK285241); thence on a true bearing of approximately 86° for a distance of approximately 21,85 kilometres to a point (grid reference QK503253); thence on a true bearing of approximately 180° for a distance of approximately 23,4 kilometres to the starting point.

The rights granted under this order may be exercised for a period of 2 years with effect from the 1st of July, 1991, to the 30th of June, 1993, inclusive.

LABOUR RELATIONS ACT, 1985

Order to Rectify an Unfair Labour Practice

I, Ignatias Takaidza Chigwendere, being Chairman of the Labour Relations Board, having taken cognisance of the matter between I. B. C. Munyaradzi, of P.O. Box 969, Harare, and Southampton Assurance Company of Zimbabwe Limited, of same address, do hereby find the company guilty of an offence in terms of section 142 as read with subparagraph (iii) of paragraph (e) of section 8 of the Labour Relations Act, 1985.

The Southampton Assurance Company of Zimbabwe is hereby ordered to pay the sum of \$15000 (fifteen thousand dollars) to Mr. I. B. C. Munyaradzi, being unpaid bonuses for period 1978 to November, 1986 as determined by the Labour Relations Board on 19th March, 1991.

The Southampton Assurance Company of Zimbabwe is to pay a fine of \$2 000 or face two years imprisonment for failing to comply with the Board's determination of 19th March, 1991. The fine must be paid to Ministry of Labour, Manpower Planning and Social Welfare consolidated fund.

Both payment must be made with immidiate effect.

 - (b) may, due to shortage of staff or to technical considerations, be delayed until conditions permit its processing.
- 7. Copy must not be submitted as part of a letter or a requisition. It must appear on a separate sheet of paper, on which there is no instruction or other extraneous matter.
- 8. (1) In cases where notices have to be published in tabular form, copy must be drafted exactly as it is to appear. If printed forms for any such notices are unavailable, advertisers must prepare their own forms. While it is not necessary to include the preamble, the box-headings must be there, and, where applicable, the number of the form; for example, "Insolvency Regulations—Form 3".
- (2) In the case of a copy for tabular notices, the provision of subsection (2) of section 3 does not apply.
- 9. Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out—
 - (a) the name and address of the advertiser; and
 - (b) the debtor's code-number, if any; and
 - (c) the required date or dates of publication.
- 10. (1) If a typographical error occurs in the Gazette, it is rectified as soon as possible by a correcting note without charge to the ministry or department concerned, subject to the following conditions—
 - (a) that such error is reported to the editor within three months from the date of publication; and
 - (b) that the relevant copy, upon re-examination, is proved to be abundantly clear; and
 - (c) that the correction of such error is legally necessary;
- (2) If a drafting error is not detected before publication, the originating ministry or department is required to draft its own correcting notice, take it to the Atorney-General for vetting, and pay for such notice to be published.
 - (3) For the removal of doubt-
 - (a) a typographical error is made by a typographer;
 - (b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.
