THE following order is published in terms of subsection (2) of section 92 of the Mines and Minerals Act [Chapter 165]:

"I, Eddison Jonas Mudadirwa Zvobgo, Minister of Mines, with the approval of the President, hereby, in terms of subsection (1) of section 92 of the Mines and Minerals Act [Chapter 165], make an exclusive prospecting order, in favour

of Montezuma Mining and Exploration (Private) Limited, over the area described hereunder, in the Gweru mining district, in relation to map reference SE 35-16 Gweru and of the scale 1 : 250 000, produced by the Surveyor-General, subject to the following conditions—
