## Two Hundred and Ninth Lottery—Christmas Bonus

- (b) Based on the face value of all tickets sold, up to 25% of the total subscriptions may be reserved for Social Services, Public Welfare or relief of distress.

- (a) First—as above, second—\$50 000, third—\$25 000.
- (b) The remainder of the prize-fund will be distributed in smaller ordinary and consolation prizes.
- (c) There will be no free tickets, no introducers' prizes, no introducers' jackpot prizes and no double and treble prizes.
- (d) If in the opinion of the Minister of Finance, the prize-fund is insufficient for the purpose, the amounts of the first three prizes listed above will be reduced as directed by that Minister.

3. *The draw*

- (a) The number of all tickets sold will participate in the draw for all prizes.
- (b) If the Director is satisfied that a fault has occurred in the drawing of a prize number, a "no draw" shall be announced and the prize shall be drawn again. A ball jamming when coming out of a drum will not in itself be considered as a fault. Examples of faults—
  - (i) One or more ball appearing before the control button is pressed.
  - (ii) Control button pressed before all balls are in the drum.

- (a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the *Gazette* itself and for subsidiary legislation issued as supplements to the *Gazette*.

1. (1) Other than by prior arrangements, only original typing is accepted.

(3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7, 7b, 8, *et cetera*.

4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.
