The shareholders have not demonstrated capacity and willingness to recapitalize the institution to the required levels notwithstanding ample time that the institution was given since the expiry of their licence on 31st August, 2005. Patnel will face further capitalisation challenges in view of the \$100 billion minimum capital requirement for asset managers with effect from 30th September, 2006;
- (b) the institution had an accumulated loss of \$88,72 million as at 31st December, 2005. It is failing to attract adequate business volumes to sustain its operations;
- (c) the institution has failed to attract sufficient volumes of funds under management to sustain its operations. As at 9th February, 2006, Patnel had \$7,3 billion funds under management

(compared to an industry average of \$3,8 trillion). It is relying on related parties for business as only \$2,8 billion relates to client funds and \$4,5 billion were own funds. Patnel was conducting margin trading which is a non-permissible activity for asset managers as per the Asset Management Act [Chapter 24:26];

- (d) there is weak Board and senior management oversight as evidenced by conduct of non-permissible activities; improperly constituted board of directors; poor documentation of client mandates; inadequate treasury operations policies and procedures and lack of an appropriate IT system;
- (e) Patnel has failed to comply with a series of supervisory directives to recapitalize the institution up to the required standards.

Conditions of Acceptance of Copy

FAILURE to comply with any of the following conditions will result in the rejection of copy, and no responsibility can be accepted if such rejection should affect any date contained in such copy or any requirement of publication on a specific date.

- (a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and
- (b) the Manual of Style for the Drafting and Preparation of copy published by Printflow (Private) Limited;

which two booklets are intended for complementary use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the *Gazette* itself and for subsidiary legislation issued as supplements to the *Gazette*.

1. (1) Other than by prior arrangements, only original typing is accepted.

(2) If a drafting error is not detected before publication, the originating ministry or department is required to draft its own correcting notice, take it to the Attorney-General for vetting and pay for such notice to be published.

(3) For the removal of doubt—

- (a) a typographical error is made by a typographer;
- (b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.

SHERIFF'S SALES

Conditions of sale
