Notice of Acquisition of Agricultural Land Under Section 16B(2)(a)(iii) of the Constitution

NOTICE is given, in terms of section 16B(2)(a)(iii) of the Constitution of Zimbabwe, that the Minister of State for National Security, Lands, Land Reform and Resettlement in the President's Office hereby acquires for and on behalf of the State, the land identified and described in the Schedule for the purposes of settlement for agriculture.
