Customs and Excise (General) (Amendment) Regulations, 2020  
(No. 101)

IT is hereby notified that the Minister of Finance and Economic Development, in terms of section 235, as read with section 120, of the Customs and Excise Act [*Chapter 23:02*], has made the following regulations: —

1. These regulations may be cited as the Customs and Excise (General) (Amendment) Regulations, 2020 (No. 101).

2. These regulations shall be deemed to have come into effect from 30th March, 2020.

3. The Customs and Excise (General) Regulations, 2001, published in Statutory Instrument 154 of 2001 are amended in Part XIII by the insertion after section 144(W) of section 144(X) as follows: —

*“Rebate of duty on essential goods imported for the fight against corona virus disease (Covid-19)*

144(X)(1) Subject to this section, and subject to such other conditions or restrictions as the Commissioner may in each case determine, a rebate of duty may be granted on essential goods imported for the fight against corona virus disease (Covid-19). Customs and Excise (General) (Amendment) Regulations, 2020  
(No. 102)

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 235 of the Customs and Excise Act [*Chapter 23:02*], made the following regulations: —

1. These regulations may be cited as the Customs and Excise (General) (Amendment) Regulations, 2020 (No. 102).

2. The Customs and Excise (General) Regulations, 2001, published in Statutory Instrument 154 of 2001 are amended in section 144(L) (“Rebate of duty on engine spares and components of Air Zimbabwe”) by the deletion of the words “with effect from 1 st January, 2019 to 31st December, 2019” and the substitution of “with effect from 1st January, 2020 to 31st December, 2021 ”.
