Made and entered into in accordance with the provisions of section 80 of the Labour Act [Chapter 28:01], in a collective bargaining session between the Medical and Allied Employers Association of Zimbabwe (hereinafter referred to as the “employers” or “the employers” organisation”), of the one part, and the Medical Professional and Allied Workers Union of Zimbabwe and Medical and Allied Trades Workers Union of Zimbabwe (hereinafter referred to as “the employees” or “the trade union”), of the other part, being parties to the National Employment Council for the Medical and Allied Industry, the following was agreed and adopted—

Section 10 (*Grading, Wages and Allowances*), of the Collective Bargaining Agreement for the Medical and Allied Industry published in Statutory Instrument 93 of 2019, is amended by the parties as detailed below. Please note that these amendments incorporate Statutory Instrument 81 of 2020, *Labour Relations (Specification of Minimum Wages) (Amendment) Notice, 2020 (No. 15)*.

Wages/Salaries

Wages have been increased by one hundred and eighty-nine point four nine percent (189.49%) with effect from 1st of April, 2020 to 30th June, 2020, as tabulated below:

Collective Bargaining Agreement: Medical and Allied Industry

Cost of Living Allowance (COLA)

A Cost of Living Allowance of thirty-two point one percent (32.1%) of the new basic wage has been awarded across the board with effect from 1st April, 2020 to 30th June, 2020 as follows:

An employee, who, at the date of commencement of this agreement, is in receipt of a higher wage or more favourable benefits for his or her particular occupation than the wage prescribed in terms of this agreement and benefits thereof, shall not by any reason of this agreement, suffer any reduction in his or her wage or benefits.

Employers who are already paying above the stipulated grade minimums may consider awarding the Zimbabwe dollar value increase.

The above are only minimums and employers who are already paying above stipulated minimums or who can pay above the stated minimums may consider giving increments based on capacity.

Transport allowance

Provision on transport allowance has been amended as follows—

S.I. 205 of 2020

Where transport is not provided for, the employer shall pay a daily transport allowance of one hundred percent (100%) of the actual transport fares required by an employee to and from work in any given route within the town/city where the business is located.

COVID-19 Risk allowance

With effect from 1st April, 2020, all employers are required to pay a COVID-19 Risk allowance to all its employees reporting for duty during the COVID-19 pandemic.

Rates and quantum of the allowances, which shall be paid on *pro-rata* basis using actual number of days worked, are to be agreed in-house based on affordability and sustainability.

Declaration

The trade unions and the employers' organisation having arrived at the agreement set forth above, the undersigned hereby declare that the foregoing is the agreement arrived at and affix their signatures hereto.
