NATIONAL EMPLOYMENT COUNCIL FOR THE
INSURANCE AND PENSIONS INDUSTRY

COLLECTIVE BARGAINING AGREEMENT: INSURANCE
AND PENSIONS INDUSTRY

Made and entered in accordance with the Labour Act [*Chapter 28:01*], as amended from time to time, between the Insurance Employers Association of Zimbabwe (IEAZ) employers representatives (herein referred to as “the employers” or “the employers’ organisations”), of the one part, and the Insurance Employees Union of Zimbabwe (ZIEU) (herein referred to as “employees” or “the trade unions”), of the other part, being parties to the National Employment Council for the Insurance and Pensions Industry (NECIPI). This supplementary agreement is made in terms of the Principal Agreement (Statutory Instrument 146 of 2014).

The details of the agreement are as follows—

1. That with effect from 1st October, 2020 to 31st December, 2020 Companies/Employers in the Insurance and Pensions Industry effect a 137.95% increase on basic minimum salary on all NEC grades as per table below.
2. That with effect from 1st October, 2020, Companies/Employers in the Insurance and Pensions Industry effect grade differentials of 10% within the grades and 12% across the bands on all NEC grades.
3. That with effect from 1st October, 2020 to 31st December, 2020 Companies/Employers in the Insurance and Pensions Industry award a minimum housing allowance of \$3 500,00, per month for each NEC graded employee.

Collective Bargaining Agreement: Insurance and Pensions Industry

4. That with effect from 1st of October, 2020 to 31st December, 2020, Companies/Employers in the Insurance and Pensions Industry award a minimum transport allowance of \$2 112,00, per month grossed up for tax purposes for each NEC graded employee.
5. That Companies/Employers who are able to pay more are encouraged to do so and to advise the NEC of such awards.
6. Companies/Employers that are not able to comply with this CBA should apply for exemption to the NECIPI Exemption Committee within a month from the date of this agreement. Such applications should be accompanied by appropriate and relevant financial statements.
7. That Companies/Employers are reminded to remit NEC levies as required in terms of Statutory Instrument 146 of 2016.

Value Added Tax (General) (Amendment) (Regulations, 2021
(No. 55)

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 78 of the Value Added Tax Act [*Chapter 23:12*], made the following regulations:—

1. These regulations may be cited as the Value Added Tax (General) (Amendment) Regulations, 2021 (No. 55).

2. The Fifth Schedule to the Value Added Tax (General) Regulations, 2003, published in Statutory Instrument 273 of 2003, is repealed and substituted by the following—

“FIFTH SCHEDULE (*Section 20*)

Rate of interest for unpaid or overpaid VAT in Zimbabwe dollars

1. The rate of interest payable by the registered operator to the Commissioner or by the Commissioner to the registered operator on any amount which has remained outstanding in terms of section 39 or 45 of the Act shall be twenty-five *per centum*.

Rate of interest for unpaid or overpaid VAT in foreign currency

2. The rate of interest payable by the registered operator to the Commissioner or by the Commissioner to the registered operator on any amount has remained outstanding in terms of section 39 or 45 of the Act shall be ten *per centum* with effect from 1st January, 2020.”.

Repeal

3. The Value Added Tax (General) (Amendment) Notice, 2019 (No. 51), published in Statutory Instrument 283 of 2019, is repealed.

Capital Gains Tax (Rate of Interest) Notice, 2021

THE Minister of Finance and Economic Development, in terms of sections 26 of the Capital Gains Tax Act [*Chapter 23:01*], hereby makes the following notice: —

Title

1. This notice may be cited as the Capital Gains Tax (Rate of Interest) Notice, 2021.

Rate of interest on unpaid or overdue refunds in foreign currency

2. (1) Subject to subsection (2), the rate of interest for any month or part thereof during which tax remains unpaid shall, for the purposes of section 26 of the Act, be ten *per centum* with effect from 1st January, 2020.

(2) For the purposes of subsection (1) —

- (a) interest shall not accrue for the first thirty days after the date when the tax becomes due in terms of section 26(1) of the Act;
- (b) where an incomplete or defective return is rendered by the taxpayer and the person satisfies the Commissioner-General that such incompleteness or defect was not due to any negligence or intent to evade the payment of tax on his or her part, interest shall not accrue from the period between the date of the first return and the date when the completed or corrected return is made:

Provided that such completed or corrected return shall be made no later than thirty days after the incompleteness or defect was notified by the Commissioner to the taxpayer.

(3) The Commissioner shall pay interest at the rate referred to in subsection (1) on any amount refunded by him or her after thirty days of the date when it was paid, unless the overpayment was due to an incomplete or defective return which the Commissioner brought to the attention of the taxpayer within that period.

Income Tax (Rate of Interest) Notice, 2021

THE Minister of Finance and Economic Development, in terms of sections 48, 71 and 73 of the Income Tax Act [*Chapter 23:06*], hereby makes the following notice:—

1. This notice may be cited as the Income Tax (Rate of Interest) Notice, 2021.

Title

2. (1) Subject to subsection (2), the rate of interest for any month or part thereof during which tax remains unpaid shall, for the purposes of section 48, 71 or subparagraph (1) of paragraph 3 of the Thirteenth Schedule of the Act, be ten *per centum* with effect from 1st January, 2020.

*Rate of interest on unpaid or overpaid income tax in foreign
currency*

(2) The Commissioner-General shall pay interest at the rate referred to in subsection (1) on any amount of refund due in terms of section 48 which has not been refunded by him or her within thirty days after the date of receipt of a tax return:

Provided that where the non-payment of the refund was due to the submission of an incomplete or defective return, which the Commissioner-General brought to the attention of the taxpayer within the thirty days, the thirty-day period shall commence to run afresh from the date of resubmission of the correct or complete return.
