NATIONAL EMPLOYMENT COUNCIL FOR THE ENGINEERING AND IRON AND STEEL INDUSTRY

WAGE AGREEMENT: GENERAL ENGINEERING SECTION (SKILLED WORKERS AND GRADED JOB CATEGORIES OF EMPLOYEES)

- 1. Notwithstanding the date of signing or publication hereof, this agreement of basic minimum wage, shall be deemed to have come into operation on 1st June, 2021.
- 2. Parties have agreed to a Zero (0%) wage increment effective 1st of June, 2021 to 30th June, 2021. Hence, current wages (1st of March, 2021 to 31st of May, 2021) remain in effect for the month of June, 2021.
- 3. Further to parties agreed to a 25.8% wage increment on NEC basic wage/salary minimums across all grades with effect from 1st July, 2021 up to 31st August, 2021.
- 4. This wage agreement shall subsist subject to review by the parties to the Collective Bargaining Agreement.
