COMPETITION ACT [CHAPTER 14:28]

Notice of Initiation of an Investigation for Remedial Action in the Form of a Safeguard Measure against the Imports of Toothpaste into Zimbabwe

A. INTRODUCTION

The Competition and Tariff Commission (the Commission) has received and accepted an application for an investigation regarding remedial action in the form of a safeguard measure against the increased importation of toothpaste into Zimbabwe. Based on the information and evidence submitted with the application, the Commission found that the applicant provided prima facie evidence of a surge in imports that is causing serious injury to the Zimbabwean industry, with a causal link to these imports.

The Commission has determined that the events cited can be considered unforeseen developments. These unforeseen developments, along with the effects of obligations incurred under the GATT 1994, have contributed to the increased volume of imports, both in absolute and relative terms.

B. THE APPLICANT

The application has been submitted by Merken Investments (Private) Limited (hereinafter referred to as "Merken"). Merken is engaged in the production of a like product in Zimbabwe and is the sole producer of this product in the country, accounting for 100% of Zimbabwe's domestic production.

A non-confidential version of the application is available for inspection at the Commission's offices.

C. LEGAL FRAMEWORK

This investigation will be conducted in accordance with the Competition Act [*Chapter 14:28*] (the Act) and the Competition (Safeguards) (Investigation) Regulations, 2006 (Safeguard Regulations). Consideration will also be given to the World Trade Organization Agreement on Safeguards (the Safeguard Agreement) and Article XIX of GATT 1994, where applicable.

Any information deemed confidential must be accompanied by a non-confidential version for the public file. If a non-confidential version is submitted, the reasons for omitting specific information and the nature of that information must be provided. Additionally, a summary of the confidential information that allows for an understanding of the omitted substance should be included. In exceptional cases where a summary cannot be provided, the applicant must explain why it is not possible. This requirement applies to all parties submitting information to the Commission.

D. PRODUCT UNDER CONSIDERATION

The product under consideration, as defined in the application, is toothpaste, primarily used for cleaning and maintaining the health and aesthetics of teeth and other parts of the oral cavity, including gums.

Toothpaste is classified under the Harmonized System customs tariff code 3306.10.00, described as dentifrices, with a current Most Favoured Nation (MFN) duty of 40%. This customs classification is indicative only and does not bind the scope of the product under consideration. Import data for the product was collected by the applicant from secondary sources, along with technical information available in the public domain.

E. LIKE PRODUCT

The product produced by the Zimbabwean domestic industry is described as toothpaste, primarily used to clean and maintain the health and aesthetics of teeth and other parts of the oral cavity, including gums. Merken further asserts that the Zimbabwean domestic product and the product under consideration are technically and commercially substitutable in all respects.

F. COUNTR(IES) OF ORIGIN OF PRODUCT UNDER CONSIDERATION

The main countries exporting toothpaste to Zimbabwe are India, China and South Africa.

G. REASONSFOR THE INITIATION OF THE INVESTIGATION

The Zimbabwean domestic industry has provided evidence of serious injury resulting from a substantial increase in toothpaste imports. This increase is evident in both absolute and relative terms compared to domestic production from 2020 to 2023.

The state of the domestic industry is concerned due to the significant and widespread deterioration of performance indicators, including production, capacity utilization, sales, market share, and, most notably, profits and losses. Consequently, it has been determined that all conditions necessary for the initiation of a safeguard investigation have been met.

H. UNFORSEEN DEVELOPMENTS

The Zimbabwean domestic industry noted that the significant rise in imports is a result of unforeseen developments, particularly stemming from COVID-19 recovery policies. Major toothpaste producers, such as those in China, India, Pakistan, and South Africa, have ramped up production post-Covid, creating surpluses that need to be absorbed by global markets, including Zimbabwe. These countries are known for their cost-effective manufacturing, making their products appealing to Zimbabwean importers and further increasing import volumes.

Additionally, established trade relationships have streamlined the flow of goods, while Zimbabwe's steady population growth has heightened demand for consumer products, including toothpaste. Since 2022, the Zimbabwean government has been implementing post-Covid-19 economic recovery policies that have significantly increased the importation of toothpaste from major exporting countries. Following an involuntary pause on imports due to Covid restrictions, the reopening of trade has led to a surge in imports that has seriously harmed—and continues to threaten—the domestic industry.

I. FINDINGS OF SERIOUS INJURY AND CAUSAL LINK

The period of investigation for data analysis in this investigation extends from January 2020 to April 2024. Consequently, the information and evidence submitted by the applicant, who is the sole domestic producer of the product under consideration, covers this same period.

The surge in toothpaste imports has been a major cause of the serious injury to the domestic industry. Evidence clearly indicates a sharp rise in imports coinciding with a decline and stagnation in domestic production, capacity utilization, return on investment, profits and losses, and market share during the surge from January 2020 to April 2024.

Furthermore, imported toothpaste is being sold at prices lower than those of domestic products. While other factors, such as exchange rate fluctuations and power challenges, may have contributed to the difficulties faced by the domestic industry, the impact of imports has been the most significant and direct contributor to the injury.

Based on the information and evidence provided by the applicant, the Commission concluded that there is *prima facie* evidence indicating that the Zimbabwean domestic industry is experiencing serious injury causally linked to the recent, sudden surge in imports of the product under consideration.

J. INTERESTED PARTIES

Interested parties have 30 days from the date of the initiation of the investigation to make themselves known to the Commission, which serves as the investigating authority. All interested parties are invited to submit comments regarding the initiation of this investigation.

Requests for an oral hearing should be submitted in writing to the Commission at the address below within 45 days from the date of the investigation's initiation, stating the reasons for not relying solely on written submissions. No request for an oral hearing will be considered more than 60 days from the date of this initiation notice.

At the time of the request for an oral hearing, parties must provide the Commission with a detailed agenda and a complete version of all information to be discussed, including a non-confidential version if the information contains a confidential component. In the case of non-responses or late submissions, decisions will be made based on the best available information.

(3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7,7b,8, et cetera.

4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.

- 5. (1) Should any copy-
 - (a) exceed 10 pages of double-spaced typing on size A4 paper; or
 - (b) contain tabular or other matter which involves complicated setting; it will be classed as "lengthy" copy, and will be required to be submitted not less than 21 days before the date of closing for the *Gazette* in which it is to be published.

(2) Lengthy copy may be accepted at less than 21 days' notice if -

- (a) the work involved is of a straight forward and non-tabular nature; and
- (b) the total volume of work on hand for the time being permits its acceptance.

 Notwithstanding anything to the contrary contained in these conditions, any copy—

- (a) which is of national importance, and which is originated as a matter of urgent necessity, may, by prior arrangement, be accepted late for the current week;
- (b) may, due to shortage of staff or to technical considerations, be delayed until conditions permit its processing.

7. Copy must not be submitted as part of a letter or a requisition. It must appear on a separate sheet of paper, on which there is no instruction or other extraneous matter.

8. (1) In cases where notices have to be published in tabular form, copy must be drafted exactly as it is to appear. If printed forms for any such notices are unavailable, advertisers must prepare their own forms. While it is not necessary to include the preamble, the box-headings must be there, and, where applicable, the number of the form; for example, "Insolvency Regulations—Form 3".

(2) In the case of copy for tabular notices, the provision of subsection (2) of section 3 does not apply.

9. Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out—

- (a) the name and address of the advertiser; and
- (b) the debtor's code number, if any; and
- (c) the required date or dates of publication.

10. If a typographical error occurs in the *Gazette*, it is rectified as soon as possible by a correcting notice without charge to the ministry or department concerned, subject to the following conditions—

- (a) that such error is reported to the editor within three months from the date of publication; and
- (b) that the relevant copy, upon re-examination, is proved to be abundantly clear; and
- (c) that the correction of such error is legally necessary.

(2) If a drafting error is not detected before publication, the originating ministry or department is required to draft its own correcting notice, take it to the Attorney-General for vetting and pay for such notice to be published.

(3) For the removal of doubt-

- (a) a typographical error is made by a typographer;
- (b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.

Petroleum (Levy) Regulations, 2024

IT is hereby notified that the Minister of Energy and Power Development after consultation with the Authority has, in terms of section 57 of the Petroleum Act [*Chapter 13:22*], made the following regulations:—

1. These regulations may be cited as the Petroleum (Levy) Regulations, 2024.

2. The Authority with the approval of the Minister has imposed a levy of United States dollars (USD) 0.005 per litre to be part of the pricing of diesel and petrol, collectable upon importation of the products.

3. The National Oil Infrastructure Company of Zimbabwe (NOIC) and the Zimbabwe Revenue Authority of Zimbabwe (ZIMRA) (and its designated agents), shall be authorised to collect the petroleum levy, subject to the terms and conditions agreed upon with Zimbabwe Energy Regulatory Authority (ZERA).

4. The collected funds shall be used by Zimbabwe Energy Regulatory Authority (ZERA) for—

- (a) strengthening the compliance of the petroleum sub-sector to regulations and standards;
- (b) training and development;
- (c) procuring tools;
- (d) researching and development; and
- (e) such other related activities as may be necessary.

5. The excess funds shall be used for enhancing access to energy in rural areas, procurement and construction of properties and the funding of activities meant to promote renewable energy uptake.

Value Added Tax (General) (Amendment) Regulations, 2024 (No. 71)

IT is hereby notified that the Minister of Finance, Economic Development and Investment Promotion has, in terms of section 78 of the Value Added Tax Act [*Chapter 23:12*], made the following regulations:—

1. These regulations may be cited as the Value Added Tax (General) (Amendment) Regulations, 2024 (No. 71).

2. The Value Added Tax (General) Regulations, 2003, published in Statutory Instrument 273 of 2003 (hereinafter referred to as the principal regulations), are amended in Part I of the First Schedule by the insertion of new items after the last item number 24 as follows—

"(25) Birds' eggs, in shell, fresh, preserved or cooked.".

3. The principal regulations are amended in Part II of the First Schedule by the insertion in item 7 of the goods with the following commodity codes—
